Subject: Delegation of powers to Director General, CCRAS, New Delhi to sanction the Laptop/notebook and similar devices to the eligible Officers of CCRAs.

The Council has been receiving requests from the officers from CCRAS for issuance of the Laptop. Ministry of Finance, Deptt. of Expenditure vide their O.M. No.3(6)/2020-E.II (A) dated 27th March, 2020 have extended this facility on the ground of functional necessity to the officers of the rank of Under Secretary/Section Officers and equivalent rank subject to the condition that this shall be restricted to 25% of the sanctioned strength of these posts. The Secretaries of the Ministries/Departments may take a decision in this regard purely on the basis of functional necessity

- 2. As these powers were vested with the Secretaries of the Ministry/Department, to consider and take decision on the requests of the officers working in the Council, an agenda was placed before the SFC for delegating the powers to Director General, CCRAS for sanctioning Laptop/Notebooks and similar devices to the eligible officers of CCRAS. The SFC in its 89th meeting held on 27th October, 2020 approved the proposal subject to condition that expenditure to be met from sources other than the GIA (General) Head i.e. out of the funds allocated for various AYUSH projects like AYUSH GRID, NAMASTE Portal.
- 3. Accordingly, consequent upon the approval of 89th SFC and subject to the condition, the powers to sanction Laptop/Notebooks and other similar devices to the eligible officers of CCRAS are delegated to D.G., CCRAS, New Delhi as per para 2 above.
